



**Report on Special Projects**  
**(Amendments to SB 700, as Introduced)**

**Senate Finance Committee**  
**Virginia General Assembly**

**February 6, 2005**

## Members of the Committee:

This year, members of the Senate submitted \$47.5 million in requests for state grants to support over 100 historic landmarks and non-state agencies throughout the Commonwealth. Additionally, as you well know, SB 1129 proposed to provide a total of \$85.6 million to 19 worthy local and regional projects throughout the Commonwealth. Under the bill, these would have been funded by VPBA bonds with debt service paid by the Commonwealth.

As I've said, now is not the time to backtrack on the commitment we made to the citizens of Virginia last year to get our fiscal house in order. Our general fund debt capacity, while large, must be reserved for projects that support core services.

Beyond the "credit card" issue, it has been a few years since the Senate has had a Report on Non-State Agencies at all, given the dire fiscal situation.

These various organizations are indeed of great value to our communities and the Commonwealth as a whole. As such, all of these requests for state assistance have been reviewed with a critical eye -- but not with a blind eye. In fact, in addition to the economic development argument put forth, these organizations contribute to our quality of life in ways that can't be easily quantified.

In the end, the level of expenditure embodied in these requests was simply more than could be accommodated. Clearly, there is a pent-up need for state assistance after several “dry” years. It is my hope that with the tumult of the past several years behind us we will begin to regain our equilibrium in this area.

I am pleased to recommend to you a package of amendments totaling \$20.2 million for the second year of the biennium. I hope it will be your pleasure to adopt them.

Page 482, after line 18, insert:

"A. Grants provided for in this item shall be administered by the Department of Historic Resources.

B. Prior to the distribution of any funds, the organization or entity shall make application to the Department in a format prescribed by the Department. The application shall state whether grant funds provided under this item will be used for purposes of operating support or capital outlay. Unless otherwise specified in this item, the matching amounts for grants funded from this item may be cash or in-kind contributions as requested by the nonstate organization in its application for state grant funds. The Department shall use applicable federal guidelines in assessing the value of in-kind contributions to be used as matching amounts.

C. Any balances not drawn down by recipient organizations on June 30, 2005, from appropriations in this item shall not revert to the general fund, but shall be carried forward on the books of the Comptroller. These balances shall remain available for distribution to affected organizations until June 30, 2006, at which time any undistributed balances shall revert to the general fund, except that, in the case of organizations which have not filed an application to receive their appropriations by December 1, 2005, the Governor may direct that the undistributed balances be reverted to the general fund on that date. The Governor shall report amounts reverted and the affected organizations in the 2006 Budget Bill.
